Use this handout to ensure that you meet the application requirements and supply the required documentation with your application to ensure that you have the best chance of success.

#### **CRITICAL CARE STREAM**

Our Critical Care New Graduate Registered Nurse Program will commence on 12 February 2024 and will consists of a 12-month full time employment contract in a critical care rotation. 2x 6- month rotations through post anaesthetic care unit and intensive care unit. There will then be an opportunity to apply for a permanent full-time position at the conclusion of the new-graduate program (if eligible).

#### **ESSENTIAL CRITERIA**

- 1. Completion of your Nursing Degree (Bachelor or Masters) prior to the commencement date.
- 2. AHPRA registration prior to commencement.
- 3. Current Working with Children Check and Police Check.
- 4. Immunisation evidence (including COVID vaccination) and serology report.

#### **DESIRABLE CRITERIA**

- 1. Previous under-graduate experience in hospital setting.
- 2. Previous under-graduate placement in Critical Care environment.

### **SELECTION CRITERIA**

As part of your application, you will be required to address each of the five (5) criteria (maximum 150 words per criterion), demonstrating your ability to meet each one. During recruitment your responses will be reviewed as part of the selection process. It is important that you give each selection criteria thoughtful consideration.

#### Use the CAR approach:

- Context Describe the situation.
- Action Explain your actions. What were your actions? What did you do?
- Results Detail the result of the actions which you took.

Please provide a clear example of your understanding of the below criteria within your employment letter (recommended to relate to your clinical practice).

- 1. Display high level interpersonal, verbal and written communication skills.
- 2. Demonstrate clinical knowledge and clinical problem-solving abilities.
- 3. Demonstrate your ability to work effectively within a team.
- 4. Exhibit patient-centred care with an understanding of the professional, ethical and legal requirements of the role.
- 5. Demonstrate your understanding of the role of the Registered Nurse in applying continuous improvement and quality and safety.

Identification	- Evidence of identification and permanent residency, such as passport, Australian birth certificate, and citizenship certificate and visa information.
Working With Children Check	<ul> <li>NSW Working with Children Check (WWCC)         clearance number for paid work by visiting         https://www.kidsguardian.nsw.gov.au/     </li> <li>You must bring a WWCC clearance number to interview for verification.</li> </ul>
Immunisation	- Evidence of current immunisation in accordance with NSW Health
Referees Identify two referees in your application:	<ul> <li>One referee must be a clinical referee.</li> <li>The second referee is to be either an employer (paid or unpaid work) or another clinical referee. The names and contact details (phone &amp; email) of your two referees are to be entered with pre-employment check information prior to interview.</li> </ul>
